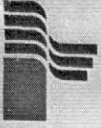

**MEMORANDUM OF UNDERSTANDING**  
**BETWEEN**  
**ISLAMABAD DIAGNOSTIC CENTER (PVT.)LTD.**  
**AND**  
**Punjab Police**

This Memorandum of understanding (MOU) is made effective from 1<sup>st</sup> July 2022 between Islamabad Diagnostic Centre (Pvt) Ltd, incorporated and registered under the companies Ordinance 1984, and having its registered office at Kohistan Road, F-8 Markaz, Islamabad (hereinafter referred to as "Diagnostic Centre" which expression shall include its representatives and successors in interest and assignees) of one-part and Punjab Police. Hereinafter referred to as "the client" which term, wherever the context so admits, shall include its successors and assignees) of the other part. Client and Diagnostic Centre may hereinafter be referred to individually as "party" and collectively as "the Parties". The Parties do hereby recite as follows:

That the Diagnostic Centre is ready and willing to provide in-house diagnostic services to the patients referred by the client (hereinafter referred to as "patients") as required. Now, therefore, in consideration of the premises and subject of the terms and conditions hereinafter set forth, the parties through this MOU do hereby mutually agree as follows:

1. This MOU shall be valid from the effective date up to **One year** that may be terminated by either party by giving one month's prior written notice to the other party.
2. The Diagnostic Centre will provide discount to client on various tests/procedures on prevailing **Cash Rates** as under. Further, Diagnostic Centre can revise its General Rates at any time and these will be applicable to Client automatically.
  - **Laboratory Tests** = 35%
  - **Imaging Tests** = 25%
  - **Covid-19 PCR** = As per Actual
  - **Outsourced Tests and Contrast** = As per actual
3. The Diagnostic Centre will provide diagnostic services to the client on **Cash terms** for patients entitled as per agreed terms & conditions.
4. The Diagnostic Centre is not specifically authorized to handle medico-legal cases. Therefore, medico-legal cases are excluded from the scope of this MOU.
5. The Diagnostic Centre will do its utmost to provide diagnostic facilities within the scope of this MOU. However, if such facilities or services are not available because of being utilized at full capacity then non-provision of such facilities and/or services will not be considered as a breach of this MOU by the Diagnostic Centre.

6. The Client shall provide a means of positive patient identification to certify eligibility. All patients must present to the Diagnostic Centre referral Card/employee card for getting all agreed diagnostic services.
7. The Client agrees to honor the policies, rules and procedures established from time to time by the Diagnostic Centre.
8. The Diagnostic Centre expects the patients to comply with all rules, procedures and formalities of this MOU and the Diagnostic Centre may refuse in providing services of the patients if such compliance is not fulfilled. The Client will ensure that the patients comply with the procedures laid down by the Diagnostic Centre.
9. The Diagnostic Centre aims to provide the highest quality of diagnostic services commensurate with the international standards. However, it cannot guarantee the favorable results of the medical services rendered.
10. Patients can collect their records personally (upon positive proof of identification) or through their authorized representative with a letter of authority & diagnostic center service receipt for this purpose.
11. To facilitate the working of this MOU, the department/organization shall inform its beneficiaries/employees about this MOU and disseminate information about the Diagnostic Centre's services.
12. The department/organization shall not assign its rights and obligations under this MOU without consulting the Diagnostic Centre.
13. All notices, reports and other communications required by the MOU shall be in writing and shall be deemed given when delivered by courier or by hand to the designated representatives of the parties at the addresses specified below.
14. The Clients, Employees and their immediate family members (subject to availability of CNIC / Form B) will also be covered for the available diagnostic services.
