MEMORANDUM OF UNDERSTANDING

PARTICULARS

This memorandum of understanding is made on 5th day of August, 2019

BETWEEN

"Punjab Police" having its Head Office at Church Road, Old Anarkali, Lahore through Mr. Shariq Kamal Siddiqui, Deputy Inspector General of Police, Welfare Punjab on behalf of Inspector General of Police, Punjab hereinafter called the First Party.

AND

Synd Omer, Nazar Shah, Chairman Aspire Group of Colleges and Savvy Schools having its Lahore Office at 23-D/I, Sir Syed Road, Gulberg-III, Lahore hereinafter called the Second Party.

PURPOSE

Whereas, the purpose of this MOU is to establish collaborative relationship between "Punjab Police" and Aspire Group of Colleges, AGS and Savvy Schools to provide quality education facilities to the children of "Police Shuhada" and the police officers/officials who remain on duty round the clock for the protection of lives and properties of the citizens. - This offer will be valid for Punjab Police Officers only. Change in designation will not affect the offer structure.


I hereby certify that the children of all the police officers are eligible for tuition fee concession and benefits as per the offer structure.

- i. 100% discount for children of "Shuhda" of Punjab Police shall be granted.
- ii. 50% Discount shall be granted for the children of all serving officers/officials of the Punjab police.
- iii. In case a student avails 100% fee concession on merit, no further discount shall be granted.
- iv. In case a student avails free education on merit, no further discount shall be granted.

This MOU is at-will and may be modified by mutual consent of authorized officials from Aspire Progressive Learning (Pvt.) Ltd. and Punjab Police. This MOU shall become effective upon signatures by the authorized officials from Aspire Progressive Learning and Punjab Police and will remain in effect until modified or terminated by any one of the partners after mutual consent.
