

## MEMORANDUM OF UNDERSTANDING

orandum of Understanding (MoU) is made between:

KIDNEY & LIVER INSTITUTE AND RESEARCH CENTER, a body established through an Act of Punjab Assembly having its registered office at One Avenue, Opposite DHA Phase VI, Lahore (hereinafter referred to as "The Hospital" which expression shall include its representatives, successor-in-interest, and assigns) of the one part,

And

THE POLICE DEPARTMENT, GOVERNMENT OF THE PUNJAB having its registered office at Central Police Office, 4-Church Road, Lahore (hereinafter referred to as "The Punjab Police" which, wherever the context so admits, shall include its successors and assignees) of the other part,

The Punjab Police and The Hospital may be referred to individually as "Party" and collectively as "the Parties".

### PRINCIPAL AGREEMENT:

The Parties do hereby agree:

That The Hospital is ready and willing to provide liver and kidney transplant services to The Punjab Police for its serving members / employees referred to as "patients" as required by The Punjab Police.

And

That The Punjab Police is ready and willing to avail such services.

Now, therefore, in consideration of the premises and subject to the terms and conditions hereinafter set forth, the parties through this MoU do hereby mutually agree as follows:

- 1. This MoU shall become effective from the date of signing and shall remain valid for a period of one (01) year thereafter, unless reminated by either party as per the termination clauses given hereafter.
- 2. The Hospital aims to provide the highest quality of medical services commensurate with available international standards, however, it cannot guarantee the favorable results of the medical services rendered.
- 3. The Hospital will provide only Liver and Kidney Transplant services to the patients referred by The Punjab Police.

4. The Punjab Police agrees to honor the policies, rules and procedures established/as amended from time to time, by The Hospital. The Punjab Police shall also ensure that the patients referred to comply with the rules and procedures laid down by The Hospital.

## APPROVALS AND PAYMENTS

- 5. The Hospital shall need a pre-admission authorization/approval for the patients referred by The Punjab Police
- 6. For all cases, The Hospital requires an advance payment within a period of <u>15 days</u> prior to start of services.
- 7. The Punjab Police shall pay Rupees one million (Rs. 1.0 million) for every transplant case whereas the rest of the cost will be financed by the Hospital as per its financial screening policy.

## TERMINATION / ARBITRATION / LITIGATION

- 8. Either of the party can terminate this MOU by serving one-month prior written notice, duly served at the official addresses given in this MOU.
- 9. For any dispute arising between the parties, if the parties agree to settle out of court of law, an arbitration committee, consisting of at least three members, shall be appointed with mutual consent and agreement of the parties, who shall evaluate the disputed matter and shall recommend a consensus decision for its settlement, which both parties shall accept.
