DURATION

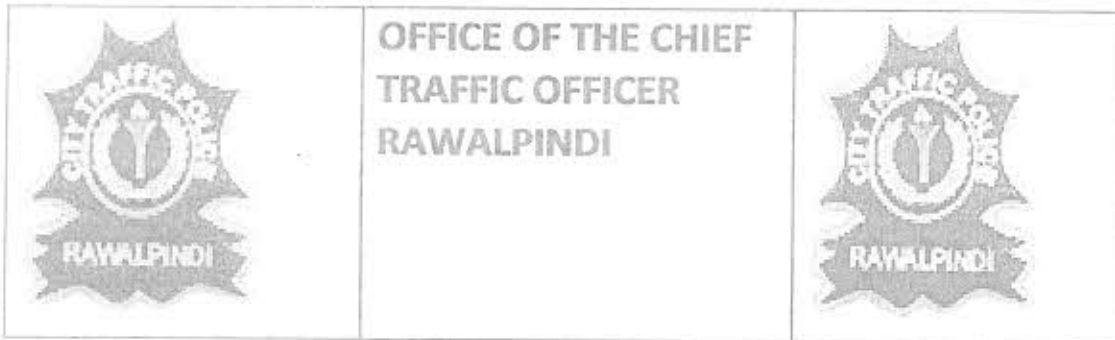
