

# MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (the "MOU") was entered into on 24-08-2020 between Aspire Group of Colleges, Gila Didar Singh and G.A.P Punjab Hills, G.A.P.

WHEREAS the Parties desire to mutually certain terms and conditions stipulated as follows

NOW THEREFORE in consideration of the mutual promises and covenants contained herein, the Parties agree as follows:

**Purpose and Scope.** The Parties intend for this MOU to facilitate the creation and structure for any and all possibly anticipated binding agreements for the **Better education facilities to the children of policemen.** This MOU should not establish or create any type of formal agreement or obligation. Instead, it is an agreement between the Parties to work together in such a manner to encourage an atmosphere of collaboration and all use in the support of an effective and efficient partnership to establish and maintain the MOU in accordance with regards to all matters relating to security of the college premises.

**Objectives** and Parties agree as follows:

1. 40% fee scholarship for the children of policemen employed in Punjab Police Gujranwala.
2. Police Department will provide its services regarding security matters and collaborate the college administration in coping up the crimes or illegal activities inside college premises.
3. The Parties shall not be restricted by the Parties to the Government from their employment or participation with any other public or private entities, agencies or organizations.
4. The Parties shall mutually contribute and take part in any and all phases of the planning and development of security of the College to the fullest extent possible.
5. This MOU is not intended to create any rights, benefits and/or trust.
6. This MOU shall be in between the Parties.
7. This MOU shall in no way obligate either Party to supply funds to maintain or to sustain the purpose of the MOU.

**Term.** This Agreement shall commence upon the Effective Date as stated above and will continue until 24-08-2021

**Termination.** This Agreement may be terminated at any time by either Party upon 30 days written notice to the other party.

**Representations and Warranties.** Both Parties represent that they are fully authorized to enter into this Agreement. The performance and obligations of either Party will not violate or infringe upon the rights of any third-party or violate any other agreement between the Parties, individually, and any other person, organization, or business or any law or governmental regulation.

**Indemnity.** The Parties each agree to indemnify and hold harmless the other Party, its respective affiliates, officers, agents, employees, and permitted

...errors and assigns against any and all claims, losses, damages, liabilities, penalties, punitive damages, expenses, reasonable legal fees and costs of any kind or amount whatsoever which result from the negligence of or breach of this Agreement by the indemnifying party, its respective successors and assigns that occurs in connection with this Agreement. This section remains in full force and effect even after termination of the Agreement by its natural termination or the early termination by either party.

**Limitation of Liability.** UNDER NO CIRCUMSTANCES SHALL EITHER PARTY BE LIABLE TO THE OTHER PARTY OR ANY THIRD PARTY FOR ANY DAMAGES, LOSSES OR PROFITS FROM ANY PART OF THIS AGREEMENT SUCH AS, BUT NOT LIMITED TO, REVENUE OR ANTICIPATED PROFIT OR LOST BUSINESS, COSTS OF DELAY OR FAILURE OF DELIVERY, WHICH ARE NOT RELATED TO OR THE DIRECT RESULT OF A PARTY'S NEGLIGENCE OR BREACH.

**Severability.** In the event any provision of this Agreement is deemed invalid or unenforceable, in whole or in part, that part shall be severed from the remainder of the Agreement and all other provisions should continue in full force and effect as valid and enforceable.

**Waiver.** The failure by either party to exercise any right, power or privilege under the terms of this Agreement will not be construed as a waiver of any subsequent or further exercise of that right, power or privilege or the exercise of any other right, power or privilege.

**Entire Agreement.** The Parties acknowledge and agree that this Agreement constitutes the entire agreement between the Parties. In the event that the Parties execute any other agreement or modify any term, they shall do so in writing, signed by both parties.
