BACKGROUND

Because of atmospheric changes and physical wear and tear, most of the traffic wardens are suffering into multiple diseases those are purely because of polluted environment and other likewise reasons. However, in the absence of a dedicated Police Medical Unit/Hospital, officials of this unit are facing great difficulties during treatment process.

COOPERATION FRAMEWORK

City Traffic Police, Lahore aimed to provide a facility of clinical assessment and radiological investigative facility to Traffic Staff working in Lahore and their limited family member at discounted rates through the active support of Alnoor Diagnostics Centre situated in Lahore.

- > 30% discount on Pathology Laboratory Standard Rates.
