MEMORANDUM OF UNDERSTANDING

- 1. This memorandum of Understanding is entered into on 19th Day of March, 2024 by and between Lions of Labore Welfare Organization #, Lions Medical Complex, through its Chairman and Dr. Usman Anwar, Inspector General of Police, Punjab, collectively "the Parties."
- WHEREAS, the Parties desire to enter into an agreement to offer discounted medical surgeries/procedures for wards of Martyrs and In-Service Officials of Punjab Police to be redeemed at Lions Medical Complex of Lions of Labore Welfare Organization @, Labore.
- 3. The Parties agree to the terms as follows:

100% free procedure for Phaco cataract surgery & Cornea transplant for wards of Shuhada.

100% free Comea donation for serving employees of Punjab Police on priority basis. However, the procedural / surgical cost incurred on the transplant will be borne by the Punjab Police.

50% discount on all surgical procedures of Eye & Dental for wards of Shuhada.

25% discount on all surgical procedures of Eye & Dental for serving employees of the Police Department.

The parties will support each other to control eye diseases in public through awareness campaigns and community education by providing opportunities and access, to the said welfare organization for seminars/conferences.
