MEMORANDUM OF UNDERSTANDING

This memorandum (MoU) is made on November 06, 2023 between Police Department, Government of the Punjab, hereinafter referred to as the "Punjab Police", which expression shall include its successors and assignees of One Part, and the Lahore Leads University, hereinafter referred to as the "University", which expression shall include its representative and assignees of the Other Part, for special discounts in tuition fees for the children of officers/officials of Punjab Police (martyred, deceased, retired and serving), on terms and conditions mentioned as below:

- The Lahore Leads University shall provide fee discounts to the children of employees (Shuhada/Serving/Deceased) of Punjab Police who are studying at Lahore Leads University.
- Student getting concession will have to abide by the prescribed criteria vis-a-vis other students.
- Students will have to maintain of GPA 3 in every semester in order to continue availing the concession.
- 4) Students desirous of availing special discounts in fee shall route their applications along with requisite documents to the management of Lahore Leads University through Head office of Punjab Police (Entries on School Management system are mandatory).
- Any direct application for concession in fee shall not be entertained.
- 6) The percentage of fee concession as agreed between parties is at the following rates:-
