## Memorandum of Understanding

This Memorandum of Understanding ("MOU") is entered on November 02, 2023

### BY AND BETWEEN

1. **Saleem Memorial Hospital (SMH)**, through Mr. Shahzad Saleem, its Chairman, (Hereinafter referred as "First Party", which expression shall, unless specifically excluded or repugnant to the context, be deemed to mean and include its executors, administrators, legal representatives, assignees and nominees), of the one part.

### AND

**Police Department**, Government of the Punjab, through Dr. Usman Anwar, Inspector General of Police, Punjab, Lahore. (Hereinafter referred as "Second Party", which expression shall, unless specifically excluded or repugnant to the context, be deemed to mean and include its executors, administrators, legal representatives, assigns and nominees), of the other part.

(Both, the First Party and the Second Party, shall collectively be referred to as "the parties")

2. WHEREAS the First Party is engaged in provision of OPD & IPD medical services to Punjab Police Employees (Serving, Retired, Deceased and Shaheed) and their spouses and children under age 21 on discounted rates applicable on cash transactions only as detailed hereunder:



3. SMH has introduced a walk-in clinic service with a consultation fee of Rs. 1,000/- (timings from 10:00 Am to 4:00 Pm) with a senior Registrar. 25% discount will be available here.
4. SMH reserves Welfare fund of Rs.3,000,000/- for deserving employees of Punjab Police for 12 months, depending on Approval via mechanism agreed between both parties.
5. Prices can be revised/ increased anytime without prior intimation.
6. This MOU will be valid for one year which can be extended with mutual consent of the parties.
7. This MOU can be terminated by either party by giving 30 days prior written notice

**NOW** the Parties desire to memorialize the terms and conditions of their anticipated endeavor hence this MoU.


