**Memorandum of Understanding
Between
Punjab Police–Government of the Punjab

Punjab Group of Colleges, Hadaf Colleges, Allied Schools, EFA School System

This memorandum of understanding (MoU) is made on November 23, 2023, between Punjab Police–Government of the Punjab here in after referred to as the Punjab Police–Government of the Punjab which expression shall include its successors and assignees of ONE PART and THE EXECUTIVE DIRECTOR, PUNJAB GROUP OF COLLEGES, HADAF COLLEGES, ALLIED SCHOOLS and EFA SCHOOL SYSTEM, here in after referred to as the Colleges and the Schools, which expression shall include its representative and assignee of the OTHER PART, for special discounts in tuition fee for the children of officers/officials of Punjab Police martyred and serving , on terms and conditions, mentioned herein below:-

1. The Punjab Group of Colleges, Hadaf Colleges, Allied Schools and EFA School System, shall provide Fee Discounts to the children of employees (Shuhada and Serving) of Punjab Police–Government of the Punjab who are either studying in the College under (02) years program or those studying in the schools.
2. Students getting concession will have to abide by the prescribed criteria vis-à-vis other students.
3. A student desirous of availing special discounts in fee shall route his/her application along with requisite documents, to Principal of Punjab College, Hadaf College or the Allied Schools, EFA School System, through the Punjab Police–Government of the Punjab. Entries on the portal are mandatory.
4. Any direct application for concession in fee shall not be entertained.
5. In witness whereof, the parties through their duly authorized representatives, have executed this MoU on the days and dates set out below, and certify that they have read, understood, and agreed to the terms and conditions as set forth herein.
