No. /SPO: This order disposes off show cause notice bearing No.1768/SPO, dated 25.01.2017, issued to C.E.O of M/s Regency Solutions (Pvt) Ltd. Area No.04 Mz Floor, Al-Qadir Heights-1, Babar Block, Lahore.

- 2. Brief facts of the case are that AIG/Logistics submitted indent for the purchase of 765 Computer Core i7 alongwith accessories and original licensed Window 10-Pro &MS Office 2016. After due process, M/s Regency Solutions (Pvt) Ltd. was awarded contract bearing No.26202/SPO, dated 16.11.2016 for the supply of 765 Computers @ Rs.99,999/- each at total cost of Rs.76,499,235/ for Front Desk (Reception Rooms) established in different police station of Punjab. The delivery date was fixed as 16.12.2016 or earlier. The delivery date has been elapsed, however, the store has not been delivered till date. Due to failure in supply of store, show cause notice was issued to M/s Regency Solutions (Pvt) Ltd., containing said allegations with the directions to submit the written reply within 07 days. The firm submitted its written reply to show cause notice on 03.02.2017, stating therein that due to change/revision of rules of State Bank of Pakistan in terms of advance payment, it couldn't make the payment to manufacturer, which caused delay in consignment delivery. The firm further asked for time of 40 days for complete delivery.
- 3. The C.E.O of firm was called for personal hearing on 24.02.2017, however, representative of firm namely Mr. Ahmed Bilal, Marketing Manager, attended this office on behalf of C.E.O. He reiterated the same version as put forth in the written statement. He was given ample chance to provide any documentary proof about financial transaction or order confirmation of by the manufacturer (Lenovo) for supply of store. But, he couldn't provide even a single documentary proof to establish his version.
- All the relevant documents and written statement of C.E.O of firm has been perused minutely which reveals that the contractor entered into contract after agreeing / signing the terms & conditions. The contractor has breached the terms and conditions of the contract, failed to execute the contract and has become defaulter in terms of clause 18 (v) of the bidding documents as well as violated the PPRA Rules 2014. Due to failure in supply of computer, work of newly established Front Desk has affected adversely.

5. Upon receipt on non-cogent and unjustified reasons given by the firm in response to Show Cause Notice dated 25.01.2017, the contract No.1768/SPO, dated 25.01.2017 awarded to M/s Regency Solutions (Pvt) Ltd. for the supply of 765 computers is hereby cancelled. The firm, is hereby black listed for period of three years, under rule 21 of PPR-2014. The main reasons for black listing are non-fulfilling of contractual obligation and non-execution of the contract as per its letter and spirit. Moreover, the 10% performance guarantee of firm amounting to **Rs.7,654,000/-** deposited in the shape of Call Deposit Reports (CDRs) is also forfeited due to failure in contracted supply of Computer Core i7, on due delivery date.
