BACKGROUND

It will apply to all Unique Schools, Colleges and Unique Science Academy campuses in Lahore.

This Joint Venture will work for next one year from 01.04.2019 to 31.03.2020 and can be extended upon the willingness of both the parties.

ARRANGEMENTS

1. City Traffic Police, Lahore will endorse in writing the entitlement of member of City Traffic Police, Lahore for which fee concession required.
2. Unique Group of Institutions will process said data and award discounts to the children of member of City Traffic Police, Lahore.

JOINT VENTURE OBJECTIVES:-

Unique Group of Institution while exercising Corporate Social Responsibility and in recognition to the services of CTPL will join hands with City Traffic Police, Lahore for the welfare of the personnel of City Traffic Police, Lahore in the shape of providing quality education to the children's of employees of CTP Lahore with following terms of references:-
